The rental occupancy rate in the CoC is over 90%. The project took longer than expected to ramp up in its initial year as staff worked to identify vacant units and landlords willing to accept clients with significant barriers to leasing such as lack of income, prior evictions, and housing debt.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This project provides Rapid Re-housing for homeless families coming from the street or shelters. Medium-term (up to 6 months) tenant-based rental assistance and supportive services are provided. The project is a collaboration between The Center for Family Resources (lead agency) and sub-recipients, Hope Atlanta (Traveler’s Aid) and LiveSafe Resources (formerly the YWCA of NW Georgia.) These same partners collaborated on the Multi-agency Group Transitional Housing Program for almost 15 years and requested the CoC to reallocate the transitional housing program to Rapid Re-housing. This project participates in the Marietta/Cobb CoC Coordinated Entry process. Participants will share in the cost of their rent based on their ability to pay, so that the minimum amount of assistance necessary to maintain housing stability is provided. The project follows a low barrier, Housing First approach and does not screen out participants for having a history of substance abuse, having a criminal record (with exceptions for state-mandated restrictions), or history of domestic violence. One of the sub-recipients, LiveSafe Resources, provides services for victims of domestic violence and will serve this population. Case management will play a central role in helping participants develop residential stability. Participants will be required to have a minimum of one case management meeting per month. Participants will be encouraged to participate in supportive services such as life skills, employment, and educational programs but will not be dismissed from the program for failure to participate, make progress on a service plan, or for other activities not included in the lease. Case managers will assist participants to make appropriate housing choices supported by their budget and to negotiate a lease. They will conduct rent reasonableness tests, lead-based paint certifications, and habitability standards prior to the client’s signing a lease. Assistance with the cost of day care, transportation costs, mental, and/or physical health care may be provided as needed. Participants will be encouraged and assisted to access all eligible mainstream benefits to increase income and stability. Life skills classes provide training on landlord/tenant issues, budgeting, communication skills, parenting, and other consumer issues. This project is needed because families with children are one of the largest subpopulations of homeless persons in the CoC. We anticipate that a total of 53 families, 170 persons, will be served during the grant term. The project will follow all Cobb CoC HMIS and GA HMIS guidelines.
