The rental occupancy rate in our community is over 90%. The process of locating vacant units and landlords willing to work with clients who have significant housing barriers continues to be a slow process.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This project provides Rapid Rehousing for homeless families coming from the street or shelters. Short-term tenant-based rental assistance and supportive services are provided for up to 3 months to assist families to obtain and remain in permanent housing. Assistance is limited to a maximum of \$3,000 per household. Participants share in the cost of their rent based on their ability to pay, so that the minimum amount of assistance necessary to maintain housing stability is provided. The project participates in Coordinated Entry. Case managers assist participants to make appropriate housing choices supported by their budget and to negotiate a lease. Rent reasonableness tests, lead-based paint certifications, and habitability standards are conducted prior to the client's signing a lease. CFR utilizes a strengths-based program model to assist families to develop skills and resources leading to greater self-sufficiency and housing stability. Case management plays a central role in helping participants develop residential stability. Participants are required to meet with the case manager once per month and to establish short and long-term goals to address their housing stability. CFR's employment program offers unemployed or underemployed participants assistance with resume development, job search skills, computer skills, GED, etc. Assistance with the cost of day care, transportation costs, mental, and/or physical health care may be provided as needed. Participants are encouraged and assisted to access all eligible mainstream benefits to increase income and stability. Life skills classes provide training on landlord/tenant issues, budgeting, communication skills, parenting, and other consumer issues. We anticipate the project will serve a total of 13 families, 46 persons during the grant year. All beds in the project are covered by HMIS. CFR follows all Cobb CoC HMIS and GAHMIS guidelines. It is needed in the CoC because households with children are one of the largest segments of the homeless population in the CoC.
