3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This SHP project helps to provide transitional housing and services to homeless, addicted men. It is a State Licensed residential substance abuse treatment program. Many of our residents are referred from other service providers, family members and from elsewhere in the community; some are also self-referred. A key component of our outreach initiatives is the Winter Shelter Program we operate on the coldest nights of the year.

Residents are housed in a 24 bed facility built in 2001 that consists of 12 double-occupancy bedrooms, with shared bathrooms and a common kitchen. The building is completely handicap accessible and has office and classroom space. Other program and recreation space is available in an adjacent building, which also houses an additional 23 beds serving the first phase of the program. The campus is located on a public transportation bus line and within walking distance of a no-cost health clinic, a county hospital and two public parks.

Anticipated program outcomes include the following:

- A minimum of 75% of residents will maintain or increase their income while in the program.
- A minimum of 70% of those who exit the program will exit to stable housing.
- A minimum of 50% will gain or maintain private health insurance.

This long-term residential program is consistent with the overwhelming weight of data that confirms the benefit of long-term treatment. Residents may stay in the program for up to two years, although that is extremely rare. The average length of time for those who successfully complete the program is 11.5 months.

This is the only program of its kind in Cobb County and is the largest residential recovery program for homeless, addicted men in the North Metro Atlanta area. All four addiction counselors on staff are Certified Addiction Counselors (CAC). Two are CAC Level II counselors. In addition, a Certified Clinical Supervisor (CCS) and a Certified Anger Management Specialist (CAMS) is on staff. The professional staff is supported by case managers and a life skills program coordinator with extensive experience serving the needs of homeless, addicted men and their families.

The Extension has a long history of service to the community and has been providing addiction recovery services for well over 10 years. During this time we have marshaled resources from throughout the community that includes both professional and non-professional volunteers, as well as financial and in-kind contributors, whose effort, combined with the staff, board of directors and a host of public and private institutional funders, make The Extensions Residential Recovery Program one of the most successful and cost-effective programs in the country.
