3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Marietta/Cobb CoC is part of the Georgia regional ClientTrack HMIS implementation, which includes all but one of Georgia's CoCs. This grant funds a part-time Cobb HMIS Coordinator who provides technical assistance to Cobb HMIS users, monitors data quality, and is involved in all aspects of agency and CoC report generation. This includes review of data for each agency's APR, preparation and submission of the PIT, HIC, AHAR and System Performance Measures as well as providing data for the CoC application.

The Coordinator facilitates a bi-monthly Cobb User Group, providing ongoing HMIS and data quality training (using results from data monitoring) as well as information about new ClientTrack modifications and HUD requirements. Training provided at the User Group builds on and supplements the basic User and Reports training that is provided by the HMIS vendor (Eccovia Solutions) and the Lead Agency (GHFA). The User Group also serves as a forum for homeless service providers to coordinate service delivery and discuss specific Cobb data input policies that enable us to have consistency of data across the CoC.

The HMIS Coordinator works in conjunction with the HMIS Lead and the GAHMIS System Admins to provide HMIS technical support to all users within the CoC. This requires remaining up-to-date on HUD's and Federal Partner's HMIS requirements and, as more programs require the use of HMIS, providing technical assistance to a growing group of users.

Additionally, the Coordinator participates in the CoC's Coordinated Assessment planning, CoC project monitoring, and developing rating and ranking policies annually for the NOFA process. The Coordinator attends the Cobb CoC Board meetings and provides expertise on data-related issues. The Coordinator is one of two representatives from the Cobb CoC on the statewide Georgia HMIS Steering Committee.


