### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

liveSAFE Resources' transitional housing (TH) program empowers victims of domestic violence to live free of abuse. We reach Cobb County victims and loved ones through our website, yellow pages listing, 24-hour crisis line, community awareness events, and referrals from hospitals, law enforcement and public and nonprofit social service agencies.

We are using a Housing First approach to intake. We do not require a criminal background check or drug test prior to entering, and do not require participation in supportive services in order to enter or remain in the program. Having no cash income at entry is common, and a majority of clients entering with income have monthly cash incomes of just \$1,000 or less. In addition to 3 homes that can house up to 16 women and children, there are 12 apartments in a single secure building that can house up to 39. We are the only state-certified domestic violence provider in Cobb County, so the continued operation of these units is essential to protect the safety of victims in our section of metro Atlanta. Clients can remain in the TH program for up to two years, although the median stay is typically 10-11 months. Instead of paying rent and utilities, clients pay a fee of up to 30% of their gross-adjusted income.

Clients receive assistance with child care, health care, transportation, education and employment. Case Managers work with adults to develop short and long-term plans for self-sufficiency. Clients are also assisted in applying for mainstream support programs including Affordable Care Act programs, SNAP, TANF, WIC, Medicare, SCHIP, Section 8, school lunch programs, jobs programs and reduced bus fares. Case managers work closely with clients to help them move into safe, permanent housing as soon as clients are emotionally ready and family finances are stable. Our clients benefit from the coordinated services of our program partners, too. Our clients attend employment programs provided by MUST Ministries and CobbWorks. The Center for Family Resources (our CoC applicant organization) also provides programs for our clients, including GED classes and life skills training, among other services.

We provide a variety of domestic violence services using Family Violence Prevention and Services Act funds from the Department of Health and Human Services, as well. Our domestic violence services are largely funded by Victims of Crime Act, which originate from the Department of Justice and are designated by the GA Criminal Justice Coordinating Council. Through these and other programs, liveSAFE Resources has a long history of coordinating federally-funded services, proper administration of federal funding and prompt, complete reporting.
