This was a first complete year of the project and MUST spent out at 97%. MUST anticipates spending out this award at 100% in the upcoming year.

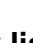

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This grant is required to fund a permanent supportive housing project for Chronically homeless and homeless families and individuals in Cobb County. The project is Dedicated Plus and focuses on individual who have substance abuse and mental health disabling conditions. It follows a Housing First model attempting and successfully serving the hardest to serve populations. From January 2018 to the present the CE data reflects that there have been 306 singles on the CE list. 123 of them have been disabled. And of those 123, 30 clients were chronically homeless.

MUST will provide two-bedroom apartments and will utilize a roommate model for individuals on which all MUST's current PSH projects is based. Families however, will not utilize this model but will instead be placed into dedicated family units. MUST is able to serve up to 22 individuals in 10 units.

All applicants are referred to the project via the CoC's Coordinated Entry system. Individuals and families are identified for the project from a variety of community sources, including the Elizabeth Inn, MUST's emergency shelter. Additionally, MUST works closely with multiple other community housing providers, to secure new referrals and to ensure excellent supportive services for our participants. Such partnerships allow MUST to have a comprehensive program that works in conjunction with our staff to provide the highest level of care to our participants.

This project works to integrate the participants into the community by assigning a case manager who helps create a housing stability plan that is tailored to meet the unique needs of the individual clients.

Case Management meetings, as well as community meetings, occur weekly and all participants are encouraged to attend. This project provides additional supportive services to participants. These services vary based upon the unique needs of each individual and family. However, MUST is equipped to provide employment and job training assistance, referrals for SOAR assistance and medical care, as well as transportation assistance to assist participants in obtaining care, food while clients are awaiting benefit approval or for those who are ineligible for benefits, employment, and/or benefits.

MUST's main outcomes for this project are to have at least 85% of clients maintain or obtain stable housing and have 55% of clients obtain or sustain income.
